1. Instructions

- 1.1. This is a **mandatory** form, required by Rotary's insurers, to provide evidence of a Rotarian's or volunteer's eligibility to work with youth. Failure to complete and lodge this form may result in insurance losses in the result of an incident.
- 1.2. These instructions must be read in conjunction with D9810's Youth Protection Policy.
- 1.3. This form must be completed for all Rotarians and volunteers who work directly with youth on Rotary programs, projects or activities, whether supervised or unsupervised.
- 1.4. It is the responsibility of the leader / manager of the respective Rotary program, project or activity to ensure that this form is completed for all volunteers and lodged for retention.
- 1.5. Completed forms and all accompanying notes on reference checks must be sent to the District 9810 Club Protection Coordinator for retention.
- 1.6. This form must be updated on the anniversary of the Rotarian's or volunteer's *Working With Children Check* renewal.
